

#### John Leslie Caldwell

September 8, 1931 – October 9, 2021

Just to the south of the great cathedral of red pines there lies a little brown cottage along Rt. 27, in which John Caldwell was born in the midst of the Depression.

Committed to his community, he along with his wife, Flo, were instrumental in developing a town youth program, ballfield, Blanchard Park, and food pantry. He served as Constable, and as Selectman for many years. He was driven by a passion to advance the townships future by acquiring forestlands, re-routing dangerous roads, obtaining our own local school system, and creating an environment for business to flourish in Northwestern Maine. Stratton/Eustis today enjoys continued fruit from his labors.

Much of John's working life was spent as a woodsman felling all kinds of species of trees. When it came to the *great white pine*, he once related that the old loggers in years gone by used to call them "heads". "Look at all those heads up there," he'd say, pointing to some conspicuous pine along a ridgetop. They truly are the majesty of the Maine woods, hence the well-deserved title of Maine state tree, and ironically, her pinecone and tassel as the state flower.

John harvested some of those mighty pine behind Pumpkin Pond, just down from the more well-known "lone pine" near Big Jim Pond. Some of those giants were well over 150-180 years old at the time of cutting, placing their sprouting to around AD 1800 or earlier - prior to Maine becoming a State. They were massive trees, each with its history extending beyond many human generations.

There is another such impressive white pine that still stands today on the northern slope of Bigelow Mountain facing Flagstaff Lake. For many decades it has stood "head" and shoulders above the forest, overwatching the Dead River Valley. Perhaps it was just a seedling reaching upward to the light when Colonel Bigelow traversed to the summit. It grew to rise above the canopy, and today can be easily identified from the picturesque vantage point just above the South Branch" Black" Bridge scenic parking area.

How typical and appropriate it is for that very tree to represent the life of John Caldwell. He stood as a "Head" in this community, his church, and his family. He stood for decades through many storms, as a "mighty man" in personal and spiritual convictions and in selfless care for others. He put Christ first in all things and that conviction kept him walking with his Lord and ultimately brought a sanctifying element to those who crossed his path, and to this town. He stood strong in caring for others. If he was hurt or offended, he returned the hand of love. If he had anger, none ever saw it. He would always quietly hold his tongue and hold out his hand to restore friendships. These are the traits and factors that impacted many lives and Stratton/Eustis is in need for other such "heads" to rise to lead, and to point men toward heaven.

While it is true that Maine is known for her mighty trees, there comes a time when each tree, no matter how strong, reaches the end of its lifespan and it becomes a hollow shadow of its former glory. Its limbs begin to fall, and ultimately one day, perhaps during a great storm, its weakened roots can no longer grasp the deep rocks beneath and in one short moment comes crashing down. Every fallen tree is a reminder of the brevity of this life, and all of us, too, will one day reach our final days of life on earth. For some, God's plan is only a few years, some even days. For others, God blesses with "threescore and ten, and if by reason of strength fourscore," and in John's case, God chose to give fourscore and ten. There is, however, one very significant difference between trees and men. Humans are not simply finite trees, and men are not temporal; they are eternal. Unlike trees, man lives on after this old life is spent here at the foot of Bigelow.

The one and, only one thing, that made John a "Great Man," was not his many efforts to be a "Good" man to his family, church, and community, but was a singular event that happened to him in the early 1960s. He, like most of us, had known since childhood that God loved the world, but he had never understood that Jesus died for him personally. He then turned from relying on his own goodness and received Christ as his personal Savior and that is what changed his entire life. That is what truly made him Great in the eyes of God, and you too, can experience God's grace. His favorite hymn reflected his life:

Years I spent in vanity and pride, caring not my Lord was crucified.

Knowing not it was for me he died, at Calvary.

Mercy there was great, and grace was free; pardon there was multiplied to me.

There my burdened soul found liberty,... at Calvary.

STRATTON – John Leslie Caldwell, 90, passed away on October 9, 2021, at the VA Medical Center at Togus. He was born on September 8, 1931, in Eustis, son of Ernest and Olive (Donahue) Caldwell. He graduated from Stratton High School seventy years ago, in the class of 1951. In July of 1951, John joined the U.S. Navy and served his country for four years of active duty, during the time of the Korean Conflict, being honorably discharged as a Boilerman, 2nd Class. On December 7, 1953, John married Florence Palmer in Philadelphia, PA, and she predeceased him on July 26, 2015.

John delivered milk via horse and wagon to Flagstaff as a teenager. He worked on many river drives, was a bus driver and janitor at the Stratton School. For many years, he worked in the woods until he retired thirty years ago.

John was a born again Christian and Charter Member of the Calvary Bible Church, where he also served as Deacon. He was president of the Stratton Youth Program from 1963 to 1979. John loved his town and its history, and for many years was on the Board of Selectmen in Eustis, until 2016. John, with his wife Flo, donated thousands of hours to the development of the Stratton/Eustis Food Pantry. During the 1970's, John and Flo were very instrumental in the development of Blanchard Park. They worked on grants for the tennis court, basketball court and for the necessary equipment. The Park was built with very little taxpayers' money, and that was because of their efforts. John was a quiet "doer" and didn't need praise. He just loved to help anywhere that he could.

John enjoyed deer hunting, walking in the woods, carpentry work, driving his skidder and running his saw. He loved his family and was proud of all of them.

John is survived by his sons, David Caldwell and wife Barbara of Columbus, MS, Bruce Caldwell and wife Mary Ann of Manchester, CT, Craig Caldwell and wife Kim of Clarksville, TN; daughter, Lynne Pease and husband Gregory of Stratton; ten grandchildren and eleven great grandchildren, scattered from Maine, Connecticut, Mississippi, Tennessee to Newfoundland, Canada; brother, Frank Caldwell and wife Judy of Stratton; many nieces and nephews. He was predeceased by his wife, Flo Caldwell, and son, James Caldwell.

Dear Friends & Neighbors:

With my stint in the Legislature drawing to a close, I want to once again thank the good people of District 117 for allowing me the opportunity to serve them at the State House. Challenges caused by the enduring COVID-19 pandemic still make daily headlines, while policymakers at all levels of government work to restore some sense of normalcy by exploring available options to preserve constituents' overall wellbeing. Maine's economy appears to be weathering these unprecedented times, as State revenue forecasters project Maine will collect \$822 million more than initially expected during the current two-year budget cycle ending in mid-2023 -- an increase of nearly 10 percent.

The Second Regular Session of the 130<sup>th</sup> Maine Legislature began January 5, 2022, and statutory adjournment is set for April 20, 2022. Legislators will attempt to finalize the various bills carried over from the First Regular and First Special Sessions, at the same time as taking into consideration new legislation deemed to be emergency in nature, dealing with budgetary matters, proposals from the Governor, initiatives submitted pursuant to statute, legislation submitted pursuant to authorized studies, and legislation submitted by direct initiative petition of the electors. Much of this business will likely be conducted virtually, so I would encourage you to monitor the Legislature's Web site if you have an interest in following proceedings.

### 2021 Assessors Report

#### Citizens of Eustis/Stratton:

The Town Assessor acts as an agent of the State and is governed by State statute and local management policy. The office is responsible for maintaining accurate records of property ownership and equitable valuation of taxable real estate and personal property located in the Town Of Eustis. This office maintains permanent records setting forth title information, descriptions of land and buildings, the valuation of all properties (taxable and exempt), tax maps showing lot size, and a list of all personal property used in trade and manufacturing. Accurate record keeping of the property cards, tax maps, deeds and transfer documents from the State is ongoing. Change in title from the deeds and declaration of value are processed on a monthly basis. Land splits and new subdivisions are tracked and recorded on all proper documents, i.e. property cards (hard copy and computer copy) and tax maps.

#### **PROPERTY TAX EXEMPTIONS & PROPERTY TAX RELIEF**

There are several forms of property tax relief available for Eustis/Stratton Residents.

These forms can be found on the Town of Eustis website @ www.Eustismaine.org

<u>HOMESTEAD EXEMPTION: (TITLE 36, M.R.S.A SECTION 863)</u>: Homeowners whose principal residence is in the State of Maine are eligible for a \$25,000 exemption on their property assessment. (This exemption is also adjusted by the certified ratio if it drops below %100). An application is available in this book and also may be attained at the Town Office. In order to qualify for the exemption, the applicant must meet the following requirements:

The applicant must be a legal resident of the State Of Maine

The Homestead must be for a permanent place of Residence

The applicant must have owned property in Maine for at least twelve months prior to April 1st, of the year for which the application is made.

Those who qualify need not reapply annually; it will apply to qualified property owners until they sell, move, or the State changes the program.

<u>VETERANS EXEMPTION: (TITLE 26, M.R.S.A. SECTION 653).</u> Any US Veteran that actively served during a federally recognized war, including those honorably discharged or retired, and is at least sixty-two (62) years of age, may be eligible for a partial tax exemption on their primary residence. Veterans receiving a pension or compensation from the United States Government for a total disability, whether service, or non-service related, may also qualify. A widow, minor, or mother of a deceased veteran may also qualify for an exemption. Applications may be obtained at the Assessor's office and must be filed with a copy of military discharge papers, such as a DD214, driver's license or State ID, and birth certificate on or before April 1st of that year.

The Veterans exemption is \$6,000. Paraplegic veterans can obtain and exemption of \$50,000 toward specially adaptive housing (the exemption is adjusted by the certified ratio if it drops below 100%).

<u>BLIND EXEMPTION (TITLE 36 M.R.S.A. Section 654).</u> Eustis/Stratton residents certified to be legally blind by their eye care professional or the Dept. of Education Division for the Blind and Visually Impaired may file for an exemption of \$4,000 towards their real estate assessment. (The exemption is also adjusted by the certified ratio if it drops below %100.)

#### INSTRUCTIONS

**SECTION 1.** Check the appropriate box related to each question. You must check all three boxes to qualify for the Maine homestead property tax exemption. If you have moved during the year and owned a homestead in Maine prior to your move, enter the address of the homestead you moved from on line 1b. Your ownership of a homestead must have been continuous for the 12-month period ending on April 1. If you did not check all boxes in this section, you do not qualify for the homestead property tax exemption. A person on active duty serving in the Armed Forces of the United States who is permanently stationed at a military or naval post, station or base in this state is deemed to be a permanent Maine resident. A person on active duty serving in the Armed Forces of the United States does not include a member of the National Guard or the Reserves.

**SECTION 2.** Enter your full name(s) as shown on your property tax bill, the physical location of your home, your telephone number, email address, and your mailing address, if different than the physical location.

**SECTION 3.** This section gives the local assessor information which may be used to determine if you qualify and should support your answers to the questions in SECTION 1. Please check the appropriate box for each of the applicable statements in this section.

At least one of the owners of the homestead must sign this document. Please file the application with your local municipal assessor. If, for any reason, you are denied exemption by the assessor, you may appeal the assessor's decision under the abatement statute, 36 M.R.S. § 841.

#### **DEFINITIONS**

**Homestead.** "Homestead" means residential real property owned by an individual or individuals and occupied by those individuals as their permanent residence. Residential real property held in a revocable living trust for a beneficiary who occupies the property as his or her permanent residence also qualifies as a homestead. A resident homeowner who is subject to foreclosure and subsequently purchases the home back from the municipality is considered to have no interruption in homeownership for purposes of this exemption.

**Municipality.** "Municipality" means any city, town, plantation, or that portion of a county in the unorganized territory.

**Permanent residence.** "Permanent residence" means that place where an individual has a true, fixed, and permanent home and principal establishment to which the individual, whenever absent, has the intention of returning. An individual may have only one permanent residence at a time and, once a permanent residence is established, that residence is presumed to continue until circumstances indicate otherwise.

Permanent resident. "Permanent resident" means an individual who has established a permanent residence.

A cooperative housing corporation may apply for a homestead exemption to be applied against the valuation of property of the corporation that is occupied by qualifying shareholders. To qualify, the corporation must complete an Application for Maine Homestead Property Tax Exemption for Cooperative Housing Corporations.

### **EUSTIS WATER DEPATMENT**

Superintendent's Report 2021

We began the year still coping with COVID issues. As essential workers we could still attend to our maintenance and office duties under the protocols of the moment. The winter months were used for routine maintenance, meter reading and trouble shooting minor issues that arise with that. We are still in a drought impact area of the State, but our well levels are still okay. We will see what snow melt and spring rains do this year. We took part with the fire department in creating and maintaining the iceskating rink-always a good challenge. We continued to do meter repairs and accuracy testing. We welcomed our summer worker back-William (Will) DeFroscia. He is a great worker and is learning a lot. We share him with the roads department, so he gets involved in a lot. I worked with Cathedral Pines on their well issue. A water line leak had lowered the water level dangerously. We found the leaks and aided the campground staff with repairs and supplied water tanks to use at the septic dump stations for rinsing camper's hoses and small, portable waste tanks. With closing the laundry and the remote bathhouse they were able to supply water. The fire department aided with filling the water tanks at the dump stations. Danny Barker loaned a tank he had-so thanks go out to him. We also are aiding the campground in getting a new, drilled well to make sure the campground has adequate water supply for all its needs. We had the reservoir and the clear well inspected and cleaned by Underwater Solutions. Hydrant flushing this year brought an unexpected challenge. The hydrant at the museum wouldn't shut off!! The crew had to temporarily shut down the main line until they could find the gate valve shutoff for the hydrant and get it closed. Then could restore water to the main line. We had to dismantle the hydrant and pull the valve and shaft out and repair it so it would operate correctly. It had jammed and broken at the break off connector. A good learning project on hydrant repairs. Commercial backflow preventor inspection was done by Provencal Plumbing of Skowhegan. We replaced the chimney at the rental house with a Metalbestos one. In October we had to dig at the curb valve for the museum as it would not shut off the water. The museum is a seasonal turn on in early summer and shut off in fall. This time it did not operate the valve. We dug down to the valve and replaced the connector rod and cotter pin that had come detached. In November we had our Sanitary Survey by the Maine Drinking Water Program inspector. This is the State agency that oversees all public drinking water systems in the state. It is conducted every three years. The inspector looks at our facility-the pumphouse, reservoir etc. as well as our recordkeeping and water sampling. He was impressed with the cleanliness of our pumphouse and found no deficiencies in our operations. We are very pleased with that. I thank Tad and Amy and Jeff Stevens for all their attention and efforts in helping me maintain our water department to a high standard. In December we did attend the annual Maine Rural Water Association conference and workshops held in person at the Samoset in Rockport. Last year the event was cancelled due to COVID, so it was good to be able to get together with our fellow water professionals. A good way to close out a successful year. We look forward to this year.

Our town and surrounding community have flourished this past year with a welcomed population increase. Many of the seasonal homes and camps throughout the area, all the way up to Coburn Gore, are now permanent residences. Years of vacant driveways are now filled with vehicles and yards are once again full of life.

With community growth, the potential for assistance grows. The fire department saw an increase of 47 calls for service over previous years in 2021. We responded to structure fires, medical calls, and assisted with mutual aid to our neighboring towns. We attended calls for trees on power lines due to significant weather events, injured hikers, and several smoke investigations. Additionally, with the drought this summer, many dry wells were filled by the department. A variety of calls were attended this past year, but the number and severity of motor vehicle accidents to which we were dispatched was significant. The majority of those accidents saw extensive vehicle and property damage, had severe life-threatening injuries, and some tragically ended with the loss of life. In some cases, inhibited road conditions due to weather and operator speed were to blame, but it bears noting that the department responded to five consecutive vehicle accidents where alcohol and other substances were a factor. On behalf of the department, I urge all members of our community and those who visit our beautiful home to, please, plan ahead and use a designated driver.

Confronted with the challenges on how to better serve the growing areas of the rural and unorganized territory we cover, we utilized the TIF Grant to update our fleet. Engine 1, which has served the Town faithfully for the past 25 years, was replaced with a 2006, 4x4 rescue pumper. The "new to us" apparatus will not only support our urban response, but will also excel with emergencies in the rural and unorganized areas we cover. Engine 1 continues to serve proudly and can now be seen caring for the residents in the Temple area.

As I approach a decade of service as Fire Chief for the Town of Eustis, I am forever grateful for the unending faith and support the community holds for our department and its amazing volunteers. It is truly an honor.

### 2021 CODE ENFORCEMENT REPORT

As we all know, 2021 began with us still dealing with the impacts of COVID-19. Building materials costs were increasing, leading us to think this might slow down building activity. Not! We issued a total of forty-five (45) permits which was less than the (49) of 2020 but it involved fifty-two (52) structures/activities! This was extremely healthy activity for our area. Sixteen (16) of the permits were for single family dwellings which is an increase from the (12) of 2020. Extremely healthy indeed.

Recreational use of the lake remains high. Both boat launch areas are used regularly, and efforts are being made to locate other suitable sites. The problem is finding sites that have area for parking. One good site upstream from the Route 27 long corner site is under preliminary discussion with Brookfield Energy. It is a good site and has suitable water depths late into the fall even with lake draw down. No, the houseboat did not launch as expected in the spring! But the potential for houseboat rental remains a discussion point for the Comprehensive Planning committee and the Planning Board. Substantial progress was made on the Cathedral Pines gazebo pavilion. Design and crafting the logs is an exacting science and art and our builder Guy Stevens has done an incredible job. It is time consuming, but the logs are all prepared to be fit together as soon as spring weather allows us to erect the structure. It will be impressive and a nice site for events and gatherings. Air B&B rentals and other temporary housing rentals is on the rise all over the State and we are not immune to that. A couple of the principal structures built were specific to seasonal, recreational rental business.

The Comprehensive Plan Committee has been meeting and working through the plan for its mandatory 10-year update. Long term affordable housing is another big concern statewide and especially in this area. Finding affordable housing for employees who do want to live and work in this area remains difficult for many. The committee will continue to work with the Planning Board as we look at changes that we may need to make to our ordinances to fit the needs of property owners large and small. Public input is especially important in this process, so do not hesitate to bring suggestions and concerns to us.

So, overall, and despite COVID, from my perspective, life remains as it should be here in Eustis Maine. We look forward to this year and all its opportunities.

# 2021 Library Report

We had 1,737 visits, 28 were in library use, of which 344 were for use of our computers and 129 were for the use of our wifi, for a total of 473 computer/wifi use and 28 were for use of the library and not computers. The remaining 1,236 was for book/item checkouts.

We had a total of 1,771 items checked out this year and we borrowed 153 books from interlibrary loan service. This year I participated in the interlibrary loan program since it costs us nothing to send them through our weekly interlibrary loan van program. We loaned 88 of our books to other libraries.

The breakdown of items checked out:

Adult books 1,387, juvenile books 267, audio books 16, videos 101 and 153 borrowed books.

We now have 6,897 books, 440 cd audio books, 938 dvds and 10 magazine subscriptions.

Total of 8,275 items, plus magazines, in our library.

We received \$2,000.00 from the Federal Government called ARPA Grants due to Covid. With that money I purchased 2 laptops for in library use, another laptop for the front desk to be used just for the Resourcemate Program that takes care of our book collection and checking books in and out at the counter. We have been having problems with the patron printer, so I hopefully have bought a better printer for them. My office computer was also getting very slow so I purchased a desktop tower with more power and a bigger screen. I consulted my circuit rider (Susanne Strout) about what to get since she knows more than I do about computers. She is very good and has helped me so much over the years.

I also have set up one of the old computers as an online card catalog. This has our new webpage on the screen. It has all the items we have in the library, plus it has a search bar to make finding items easier. Plus it may have a picture of the cover of the book and a brief description of the book. It also has a slide show of pictures taken at the library.

As always it's been a pleasure. I am so lucky to live in such a wonderful town and to have such a great job.

The members of the Dead River Historical Society would like to express our sincerest appreciation for the support received by the voters of Eustis. It is through this support the Dead River Historical Society has been able to grow and become a valuable resource for the town of Eustis, and all of the State of Maine.

The Dead River Area Historical Society is a non-profit organization, incorporated in the state of Maine in 1979 for the purpose of preserving and promoting interest in the history of the Dead River Area. Artifacts, manuscripts photographs, etc. have been donated or loaned from interested townspeople and descendants of the Dead River Areas. Collections from 1850- with all of the artifacts given from the original families of the Dead River Region. Displays include a collection of old carpentry and logging tools, china, glass, church organ, furniture from native families, a complete schoolroom, exhibits of the "lost" towns of Flagstaff Village, Dead River and Bigelow Plantations, the lineage of several native families, and a host of memorabilia from native homesteads. We have Town Reports dating back to 1921. Our town preserves a great deal of history and we readily share it.

This year we have made many changes in the museum, Stratton's First Settlers, The Stevens Family, is the first exhibit entering the building, the River Drive Exhibit has been added and enjoyed by many. Thanks to our volunteers there have been many improvements and repairs made.

We are still working on "The New Military Exhibit" which will eventually be upstairs where the old Newsroom was. Photos of our service men and women will be on the walls leading to the upstairs. Once we get at least a 10 foot stair climber for the back section of the museum making it easier for older and unabled people to get upstairs. The exhibits of these men and women who have served our country and we are so proud of will all be moved into larger quarters and a better displayed.

Money is raised each year by membership, a historical picture calendar and cookbook are printed, a brown bag auction is held at the annual dinner in November, as well as other functions and fundraisers. Over the years many improvements have been made and greatly enhanced the museum. It is more accessible year-round for schools, and those doing research on Maine History. We have several calls each year from individuals and organizations throughout the state and beyond who are doing research on these areas. The Dead River Area Historical Society builds on the strength of the

community and enriches it by serving as a valuable research center for the region and stimulates the local economy. The museum is open every weekend in July and August as well as Labor Day Weekend and year-round by appointment.

We are again asking the voters of Eustis for support to heat the museum thus preserving the artifacts. I want to start out by thanking you all for your dedication in continuing your support of the Stratton Summer Recreational Program. This is truly a dedicated program for our local children that promotes active summers and water safety. Thank you!

The past two summers have proven challenging due to COVID restrictions and precautionary measures. Our children have handled it like troopers and thankfully we had no problems to report this past summer with campers and families. I believe it is wise to continue healthy cleaning measures and policies as the years go on just to prevent multiple health issues. Masks on the bus is minimal and hopefully not necessary for long.

Thanks to Kibby Wind Power our Program received a grant of \$5,000. this past summer. This allowed us to make a very pricey white water rafting trip affordable to our 6th - 9th graders. We also purchase some new camping gear as well as six new inflatable paddle boards that were enjoyed by all!

I believe I was able to save the program money by unexpectedly pulling double duty as director and counselor both summers. Staffing difficulties is real and I have to rethink the hiring of individuals. This leads to the need to increase wages to secure 3 new responsible adult counselors. I believe I have 3 trained and responsible Jr. counselors returning. There is also the challenge of finding a new bus driver. I know that this wage needs to increase, 1: because I didn't give Hope an increase last year. 2: because it is very difficult to secure a bus driver for the hours we need.

Finally, I am forced to ask for an increase to the budget of \$43,000 for \$2,000. more. I feel I could concentrate on trying to stay local, but campout are so important four team building and life skills. The life guard is trained now for water safety and we will not have that expense of training this year. I would like to add some other trainings to provide locally, for our children that are costly, but important to our local interests. Hunting safety, archery, compass reading, and a day or two of ATV safety. Something to look into.

I write on behalf of Safe Voices to request funding support from the Town of Eustis and Stratton. Safe Voices is the only domestic violence and sex trafficking and exploitation resource center serving Androscoggin, Oxford, and Franklin counties. We write to you with the hope that the Town of Eustis and Stratton will assist us in reaching our communities and ensuring that resources are available by providing funding to our work.

Safe Voices has served residents of the Town of Eustis and Stratton through diverse advocacy services for survivors of domestic abuse and violence for 45 years. In the last year we provided support and safety planning to 953 individuals throughout our catchment area. At our shelters, we safely housed 78 adults and 37 children. We offer **free and confidential services** for everyone we work with, with the exception of our Violence Intervention Program for those who use abusive behaviors in their relationships.

- A 24-hour Helpline for survivors, service providers, and others affected by domestic violence

- Rural outreach programs: Advocacy, support and referral services in offices located in Lewiston, Farmington, South Paris, and Rumford

- Community prevention and education provided in all three counties

We at *NorthStar EMS* are pleased to be providing ambulance and community services to the town of Eustis/Stratton.

At this time of year, the Automatic Renewal terms of the *NorthStar Regional EMS Participation Agreement* call for us to inform you of the amount of your subsidy for the next fiscal year. This amount applies for the period from <u>July 1, 2022 to June 30, 2023</u>.

We are also pleased to include a picture of our financials, our budget for our current year (FY2021) and the budget for FY2022. More details are in the attachments. All documents have been thoroughly reviewed and evaluated by the members of the NorthStar Advisory Board.

**NorthStar** is proud to serve your community. With your continued support, we are providing care whenever and wherever it is needed. With five bases strategically located throughout the area, **NorthStar** provides the strength of a 24/7 regional organization while keeping its patient care operations *local* to the community.

NorthStar crews are additionally involved in thousands of hours of community service each year. CPR trainings, presentations at area schools, mock accident scenes, a house call program and a presence at fairs, festivals, and athletic events are just a few of the ways that *NorthStar* contributes back to the residents and visitors of this region.

Once again, we are continuing the same basic demographic formula we originally presented to all towns when *NorthStar* was formed in 2005. *NorthStar* has implemented cost savings and efficiencies that have allowed us to keep the subsidy amounts as low as possible. This formula, developed with the *NorthStar* Advisory Board, allocates *NorthStar*'s overall operating deficit (total expenses minus total income) fairly and equitably among all the towns and counties *NorthStar* serves. Every municipality's amount continues to be based on a single formula applied in a consistent way to each municipality's unique demographics. The attachment describes the formula and the demographics used to arrive at the subsidy amounts.

Under that formula, the amount declared for your municipality for the fiscal year beginning July 1, 2022 under Section 2.1(a) is \$\frac{\$26,206}{206}\*\$

Reminder: Under the Agreement terms, you have until <u>April 1,2022</u> to notify us if you do <u>not</u> want to renew the Agreement. <u>No action is required on your part to continue the contract under the terms in this letter.</u>

As always, your ambulance service is strong because *NorthStar* covers every square mile of its service area with equal dedication—bringing prompt response times, highly trained staff, community involvement, and multiple backup support to towns, townships, and unorganized territories. As we continue this seamless coverage, it is critical that every town and county area contribute its fair share to the support of the service.
