Andy from Absolut Septic Services has been to complain about the trash he is finding inside the portable toilet. The board said that if the problem continues, they will pull the toilet from the boat launch.

The community building is going to need some electrical work. The lions club has purchased 2 new freezers and now the breaker keeps tripping. They need to

have another circuit run to take some of the load off that one that keeps tripping. Stan has spoke to Jed and will get a quote to see if we need to get more quotes. Steve made a motion to purchase a rocking chair from Standard Chair of Gardner for Kathy's retirement, Carol 2<sup>nd</sup>. Linda, Carol, & Steve in favor. Motion passed unanimously.
