If water is shut off for non payment of the water bill, the fee is \$33.00 to restore service, plus the outstanding water bill, and a deposit may be required. During Holidays or other than normal business hours the charge is \$48.00 per hour. A collection of \$16.00 will be charged if Utility personnel visit the premises to disconnect and payment is rendered at that time.

Returned check charges are the charges incurred from the bank.
