Attending:

Steve called the meeting to order and welcomed those in attendance.

Old Business:

Review of the Rescue 1 Truck The board went over the estimate for the Truck.

Steve made a motion to move forward with the repairs for \$4118.74 Jeff 2nd Steve, Tim, Jeff, Linda, & Carol in favor Motion passed unanimously.

New Business:

Use of dump trailers at the transfer station. When they dump with a trailer it goes everywhere and then we must clean it up. We are not set up to handle dump trailers dumping into the containers.

Waste oil and Anti-Freeze Removal is a large cost to the town. The board is not in favor of not accepting it because we will then just find it dumped everywhere. Can we purchase our own barrels to minimize the cost? Are there any other companies in Franklin County? Rachel will work with Tony to see what else we can do.

The Board signed the quit Claim Deed.

Selectboard Updates:

Tim informed the Board that Leah Ross was granted permission to use the passenger van that the school purchased last year. Rachel is going to call MMA and see if we should be the one to insure her on the vehicle or if the school should. Rachel will update Tim.

Speed Tables were paved on school street in hopes of slowing the traffic down.
